[@] It shall be the duty of the examinee to obtain the signature of the invigilator on submission of the written answer script(s)/OMR(s) to him/her on each day/half of the examination.

As per CSR No. 64/17 & 10/18 for both Honours and General Course(i.e. with CHG Code) would be conducted in OMR sheets; examinees are instructed to fill up OMR Sheet(s) as per instructions printed on the OMR sheet.
